Description of the map

The map shows the Prohibition of Waiting zone on Kings Road and Clare's Court, **Kidderminster:**

Kings Road (west side): from its junction with Clare's Court for a distance of 10m in a northerly direction and 6m in a southerly direction.

Clare's Court (north side): from its junction with Kings Road for a distance of 8m in a westerly direction

Clare's Court (south side): from its junction with Kings Road for a distance of 13m in a westerly direction.
