Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON KINGS ROAD AND CLARE'S COURT, KIDDERMINSTER]

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Map of Kings Road and Clare's Court, Kidderminster and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on Kings Road and Clare's Court, **Kidderminster**:

Kings Road (west side): from its junction with Clare's Court for a distance of 10m in a northerly direction and 6m in a southerly direction.

Clare's Court (north side): from its junction with Kings Road for a distance of 8m in a westerly direction

Clare's Court (south side): from its junction with Kings Road for a distance of 13m in a westerly direction.
