Rachel read through the Expert Members Report.




#### **Comments/Questions:**

Gail said there have been some responses to the letters and the MPs have acknowledged the concerns. In the letter, the MPs have explained that they still require the Integrated Care Boards to report on the number of Annual Health Checks that they undertake every year.

# Report:

Having a Place to Live

The last SEND Preparing for Adulthood Meeting was cancelled due to clashes with other workshops and was rearranged for May so there is no highlight report this time.

Aimee updated the Board about the work she is involved in alongside Fran and Jill which is being led by Children's Services to update the SEND Delivery Plan, and part of that Plan includes the LD Strategy.

Aimee and Jill attended a workshop back in February where they spoke to lots of different parent/carers and professionals about the LD Strategy and how this was co-produced by the Learning Disability Partnership Board.

The Strategy was well received with lots of positive feedback from people at the event about the Strategy being a fully coproduced piece of work.
