# **The order under the Road Traffic Regulation Act 1984**

## **WORCESTERSHIRE COUNTY COUNCIL (A38 WORCESTER ROAD, WYCHBOLD/ UPTON WARREN AND C2084 SWAN LANE, UPTON WARREN) (PROPOSAL AND REVOCATION) (40 MPH AND 50 MPH SPEED LIMIT) ORDER 2025**

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order: -

1. That The Worcestershire County Council (A38 Wychbold) (40 MPH Speed Limit) Order 2010 (Revocation) and The Trunk Road (A38) (Worcester Road, Wychbold) (50 MPH Speed Limit) Order 1989 (Revocation) and A38 Worcester Road, Wychbold) 50 MPH Speed Limit) Order 2018 is hereby revoked in its entirety.
2. That The Worcestershire County Council (A38 Worcester Road, Upton Warren) (50 MPH Speed Limit) Order 2004 is hereby revoked in its entirety.
3. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads specified in Schedule 1 to this Order.
4. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 50 miles per hour along those roads specified in Schedule 2 to this Order.
5. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
6. This Order may be cited as Worcestershire County Council (A38 Worcester Road, Wychbold/Upton Warren and C2084 Swan Lane, Upton Warren) (Proposal and Revocation) (40 MPH and 50 MPH Speed Limit) Order 2025 and shall come into operation on XXXXX 2025

Lengths of road in the Parishes of Dodderhill and Upton Warren in the District Wychavon in the County of Worcestershire subject to the provisions of Article 3 of this Order.

A38 Worcester Road:

From a point 75 metres northeast of its junction with U42014 Mill Lane in a northeasterly direction to a point 95 metres northeast of its junction with C2084 Swan Lane.

C2084 Swan Lane:

From its junction with A38 Worcester Road for 50 metres in a westerly direction.

## **SCHEDULE 2**

Lengths of road in the Parishes of Upton Warren and Stoke Prior, in the Districts of Wychavon and Bromsgrove in the County of Worcestershire subject to the provisions of Article 4 of this Order.

A38 Worcester Road:

From a point 95 metres northeast of its junction with C2084 Swan Lane to a point 25 metres southwest of Puddle Wharf Traffic Island (B4094 Worcester Road junction)

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers then enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. That Worcestershire County Council (A38 Wychbold) (40 M.P.H. Speed Limit) Order 2010 is hereby revoked in its entirety.
2. That The Trunk Road (A38) (Worcester Road, Wychbold) (50 MPH Speed Limit) Order 1989 is hereby revoked in its entirety.
3. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 50 miles per hour along that part of A38 Worcester Road, Wychbold, in the Parish of Dodderhill, in the District of Wychavon, in the County of Worcestershire from a point 75 metres north east of its junction with Mill Lane in a north easterly direction to the northern arm of Webbs Traffic Island.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
5. All other Orders made prior to the date of this Order applying to any of the lengths of road specified in the Order are hereby revoked or varied as may be required.
6. This Order may be cited as Worcestershire County Council (A38 Wychbold) (40 M.P.H. Speed Limit) Order 2010 (Revocation) and The Trunk Road (A38) (Worcester Road, Wychbold) (50 MPH Speed Limit) Order 1989 (Revocation) and (A38 Worcester Road, Wychbold) (50 MPH Speed Limit) Order 2018 and shall come into operation on 19 April 2018.

**A38 WORCESTER ROAD**

**C2084 SWAN LANE**

from its junction with A38 Worcester Road for a distance of 50 metres in a northwesterly direction.

The map shows the proposed 40mph & 50mph Speed Limit on A38 Worcester Road, **Wychbold & Upton Warren** & C2084 Swan Lane, **Upton Warren**:

**40 miles per hour:**

**A38 Worcester Road:** From a point 75 metres northeast of its junction with U42014 Mill Lane in a northeasterly direction to a point 95 metres northeast of its junction with C2084 Swan Lane.

**C2084 Swan Lane:** From its junction with A38 Worcester Road for 50 metres in a westerly direction.

**50 miles per hour:**

**A38 Worcester Road:** From a point 95 metres northeast of its junction with C2084 Swan Lane to a point 25 metres southwest of Puddle Wharf Traffic Island (B4094 Worcester Road junction)
