Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

Map of A4104 Old Street, Upton Upon Severn and the Disabled Persons' Parking Space & No Waiting zones implemented by the above order.

Description of the map

The map shows the Disabled Persons' Parking Space & No Waiting zones on A4104 Old Street, **Upton Upon Severn**:

Disabled Badge Holders Only (Revocation of existing Limited Waiting)

Old Street, Upton (west side) - from a point 100.5m north of its junction with Backfields Lane for a distance of 6.6m in a northerly direction.

Prohibition of Waiting At Any Time on the following side and length of road in **Upton upon Severn**:-

No Waiting at Any Time (Revocation of the current Disabled Badge Holders Only).

Old Street, Upton (west side)- from a point 107.1m north of its junction with Backfields Lane for a distance of 6.6m in a northerly direction.
