### **Description of the map**

The map shows the prohibition of waiting at any time and no waiting on verges or footways on B4211 Hanley Road, **Upton:** 

**B4211 Hanley Road, Upton- (northeast side)** from its junction with the A4104 for a distance of 52m in a north westerly direction and from a point 104m northwest of its junction with A4104 for a distance of 120m in a north westerly direction.

**Southwest side)** from its junction with A4104 for a distance of 53m in a north westerly direction and from a point 96m northwest of its junction with the A4104 for a distance of 125m in a north westerly direction.
