

Map of Bowpatch Road & B4196 Areley Common, Areley Kings, Stourport and the Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting zone on Bowpatch Road & B4196 Areley Common, Areley Kings, **Stourport**:

**B4196 Areley Common (west side)** from its junction with Bowpatch Road for a distance of 11m in a southerly direction.

**Bowpatch Road (south side)** from its junction with B4196 Arley Common for a distance of 4.2m in a westerly direction
