Map of Bransford Road/Grange Lane, Rushwick and the Prohibition of Waiting zone implemented by the above order.

## **Description of the map**

The map shows the Prohibition of Waiting on Bransford Road/Grange Lane, **Rushwick: C2298 Bransford Road (south side) -** from its junction with Grange Lane for a distance of 20m in a westerly direction and 20m in an easterly direction;

**Grange Lane (west side) -** from its junction with Bransford Road for a distance of 5m in a southerly direction;

**Grange Lane (east side) -** from its junction with Bransford Road for a distance of 17.5m in a southerly direction.
