## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON BRANSFORD ROAD/GRANGE LANE, RUSHWICK]**

Worcestershire County Council have made this Order for facilitating the safe passage on the roads or any other road of any class of traffic and for avoiding danger to persons or other traffic using the roads or any other road or for preventing the likelihood of any such danger arising.

Map of Bransford Road/Grange Lane, Rushwick and the Prohibition of Waiting zone implemented by the above order.

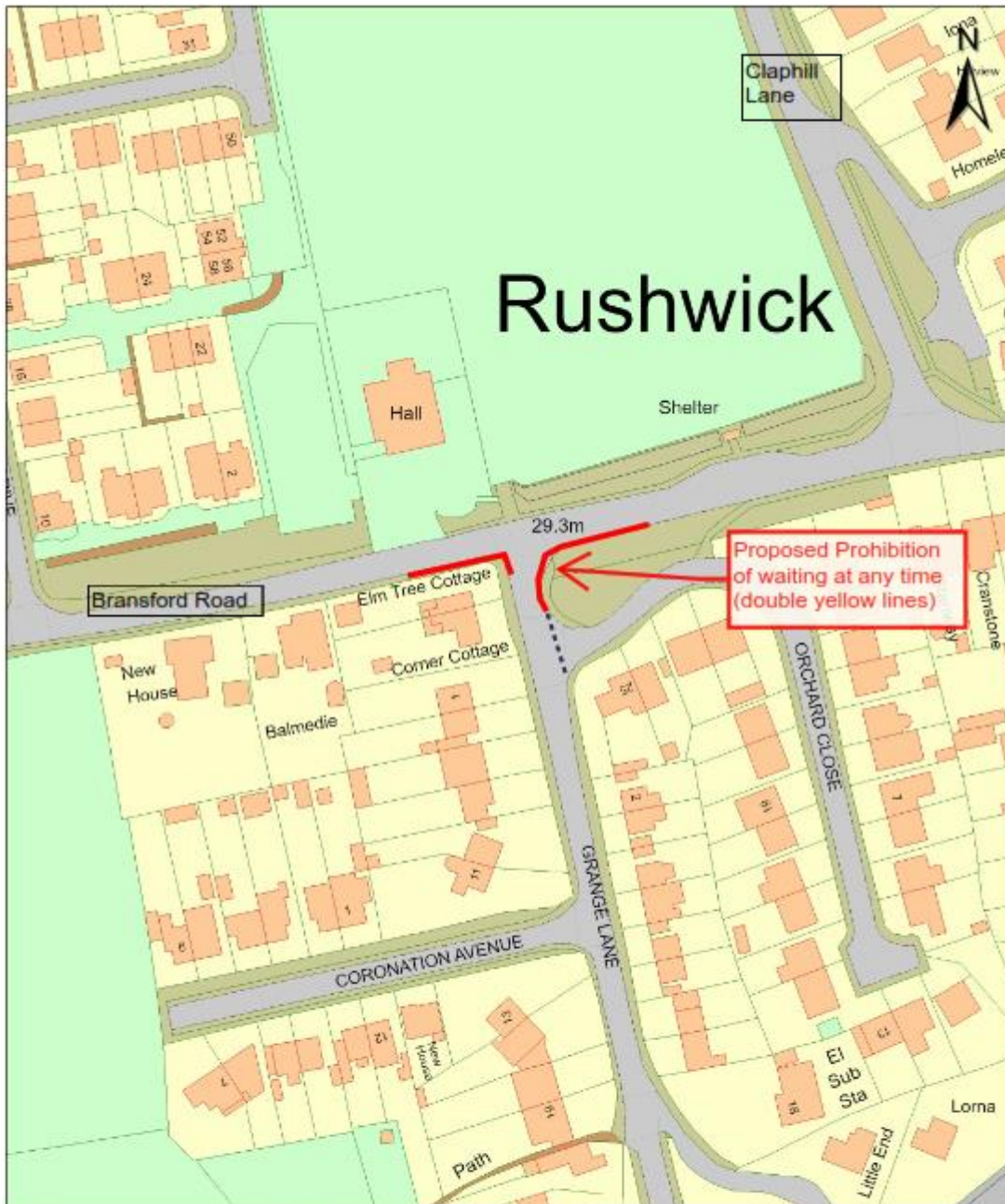
### Description of the map

The map shows the Prohibition of Waiting on Bransford Road/Grange Lane, **Rushwick:**

**C2298 Bransford Road (south side)** - from its junction with Grange Lane for a distance of 20m in a westerly direction and 20m in an easterly direction;

**Grange Lane (west side)** - from its junction with Bransford Road for a distance of 5m in a southerly direction;

**Grange Lane (east side)** - from its junction with Bransford Road for a distance of 17.5m in a southerly direction.
