Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – EVESHAM AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON BRIAR CLOSE, EVESHAM]

Briar Close (West side): from a point 9 metres south of its junction with Rudge Road for a distance of 4 metres in a southerly direction.
