## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING/PROHIBITION OF LOADING (PROPOSAL & REVOCATION) ON COURT ROAD, BARNARDS GREEN, MALVERN]**

### Description of the map

The map shows the prohibition of waiting/prohibition of loading zone on Court Road, Barnards Green, **Malvern**:

**Court Road (southeast side):** from a point 58.3 metres southwest of its junction with Barnards Green roundabout for a distance of 16 metres in a south westerly direction.
