## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (BROMSGROVE DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON EACHWAY AND HOLMES DRIVE, REDNAL]**



### Description of the map

The map shows the Prohibition of Waiting zone on Eachway and Holmes Drive, **Rednal**:

**Holmes Drive: (North side)** from a point of its junction with Eachway for a distance of 10 metres in a westerly direction. **(South side)** from a point of its junction with Eachway for a distance of 10 metres in westerly direction.
