## **Description of the map**

The map shows the prohibition of waiting zone on Longboat Lane, Stourport:

**Longboat Lane (North side)** - from a point 12.8 metres from its junction with Minster Road for a distance of 7.8 metres in an easterly direction;

(South side) - from a point 12.5 metres from its junction with Minster Road for a distance of 7.8 metres in an easterly direction.
