Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING AND REVOCATION OF LIMITED WAITING ON PROSPECT HILL, KIDDERMINSTER]

Map of Prospect Hill, Kidderminster and the Prohibition of Waiting and revocation of Limited Waiting implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting and revocation of Limited Waiting on Prospect Hill, **Kidderminster**:

Prospect Hill (south- east side) from a point 30m north-east of its junction with Worcester Street for a distance of 40m in a north easterly direction.

Revoke: Limited waiting for 1 hour, 8am-6.30pm (No return in 2 hours)

Prospect Hill (south- east side) from a point 16m north-east of its junction with Worcester Street for a distance of 54m in a north easterly direction.
