Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON STONEY LANE & STOURVALE DRIVE, KIDDERMINSTER) AND (NO STOPPING ON SCHOOL ENTRANCE MARKINGS ON STONEY DRIVE, KIDDERMINSTER]

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

The order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (STONEY LANE, KIDDERMINSTER) (NO STOPPING ON SCHOOL ENTRANCE MARKINGS) ORDER 2025

Worcestershire County Council in exercise of their powers under Sections 1, 2, 3, and 4 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as “the Act of 1984”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. Save as provided in Article 2 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop at any time on School Entrance Markings as specified in the Schedule to this Order
2. Nothing in Article 1 of this Order shall apply:-
 - (a) to a vehicle stopping on the school keep clear markings referred to in Article 1 for so long as may be necessary to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road including and comprising of the school entrance markings, or the laying, erection, alteration or repair in or near such road of any sewer or of any main, pipe or apparatus for the supply of gas, water or sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (b) to a vehicle being used for fire brigade, ambulance or police purposes;
 - (c) to a vehicle being used in pursuance of statutory powers or duties;
 - (d) to a vehicle stopping on the school entrance markings referred to in Article 1 for so long as is necessary to enable any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged to be opened or closed if it is not practicable for the vehicle to wait otherwise than on the school entrance markings.

(e) to a vehicle stopping on the school entrance markings referred to in Article 1 when the person in control of the vehicle:-

(i) is required by law to stop;

(ii) is obliged to do so in order to avoid an accident; or

(iii) is prevented from proceeding by circumstances outside his control and it is not reasonably practicable for him to drive or move the vehicle to a place not on the school entrance markings referred to in Article 1.

3. This Order shall come into operation on 7 August 2025 and may be cited as (Stoney Lane, Kidderminster) (No Stopping on School Entrance Markings) Order 2025.

(NO STOPPING ON SCHOOL ENTRANCE MARKINGS) ORDER 2025

Worcestershire County Council in exercise of their powers under Sections 1, 2, 3, and 4 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. Save as provided in Article 2 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop at any time on School Entrance Markings as specified in the Schedule to this Order
2. Nothing in Article 1 of this Order shall apply:-
 - (a) to a vehicle stopping on the school keep clear markings referred to in Article 1 for so long as may be necessary to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road including and comprising of the school entrance markings, or the laying, erection, alteration or repair in or near such road of any sewer or of any main, pipe or apparatus for the supply of gas, water or sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (b) to a vehicle being used for fire brigade, ambulance or police purposes;
 - (c) to a vehicle being used in pursuance of statutory powers or duties;
 - (d) to a vehicle stopping on the school entrance markings referred to in Article 1 for so long as is necessary to enable any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged to be opened or closed if it is not practicable for the vehicle to wait otherwise than on the school entrance markings.

- (e) to a vehicle stopping on the school entrance markings referred to in Article 1 when the person in control of the vehicle:-
 - (i) is required by law to stop;
 - (ii) is obliged to do so in order to avoid an accident; or
 - (iii) is prevented from proceeding by circumstances outside his control and it is not reasonably practicable for him to drive or move the vehicle to a place not on the school entrance markings referred to in Article 1.
3. This Order shall come into operation on 7 August 2025 and may be cited as (Stoney Lane, Kidderminster) (No Stopping on School Entrance Markings) Order 2025.

SCHEDULE

No Stopping on School Entrance Marking

Stoney Lane, Kidderminster (north side)

From a point 78.5m east of its junction with the mini roundabout at the Stourvale Drive junction for a distance of 31.2m in an easterly direction.

Map and plan of the area

Map of Stoney Lane/Stourvale Drive, Kidderminster and the Prohibition of Waiting zone and No Stopping on School Entrance Markings zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on Stoney Lane/Stourvale Drive, **Kidderminster**

Stoney Lane, Kidderminster (south side)- from its junction with the mini roundabout at the Stourvale Drive junction for a distance of 13.9m in a westerly direction and 23.2m in an easterly direction;

Stoney Lane, Kidderminster (north side)- from its junction with the mini roundabout at the Stourvale Drive junction for a distance of 9.5m in a westerly direction;

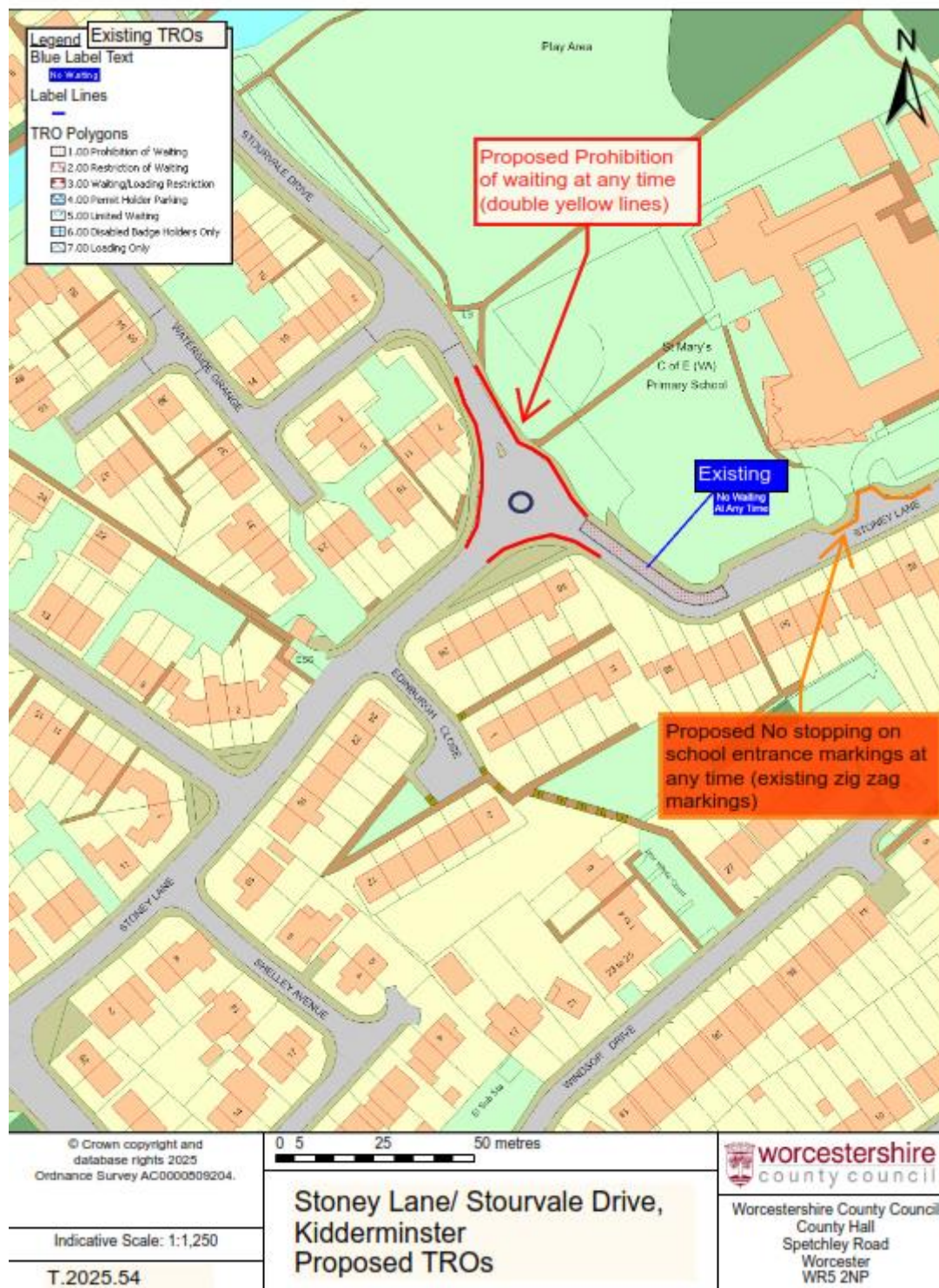
Stoney Lane, Kidderminster (east side)- from its junction with the mini roundabout at the Stourvale Drive junction for a distance of 15.7m in a southerly direction;

Stourvale Drive, Kidderminster (west side)- from its junction with the mini roundabout at the Stoney Lane junction for a distance of 37m in a northerly direction;

Stourvale Drive, Kidderminster (east side)- from its junction with the mini roundabout at the Stoney Lane junction for a distance of 27.7m in a northerly direction.

And the **Prohibition of stopping at any time on School Entrance Markings** on the following lengths and sides of road in **Kidderminster**: -

Stoney Lane, Kidderminster (north side)- from a point 78.5m east of its junction with the mini roundabout at the Stourvale Drive junction for a distance of 31.2m in an easterly direction.



Stoney Lane/ Stourvale Drive, Kidderminster Proposed TROs
