## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (BROMSGROVE DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON THE HEDGEROWS, ROMSLEY]**

## Map and plan of the area

Map of The Hedgerows, Romsley and the Prohibition of Waiting implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting on The Hedgerows, **Romsley**:

**St Kenelms Road: (Northeast side)** from its junction with The Hedgerows for a distance of 3 metres in a north easterly direction. **(Southwest side)** from its junction with the Hedgerows for a distance of 3 metres in a westerly direction.

**The Hedgerows: (Southeast side)** from its junction with St Kenelms Road for a distance of 10 metres in a southerly direction. **(Southwest side)** from its junction with St Kenelms Road for a distance of 8 meters in a southerly direction.
