- 4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 5. This Order may be cited as Worcestershire County Council (Various Roads, Abberley) (30 M.P.H. and 40 M.P.H. Speed Limit) (Revocation and Proposal) Order 2025 and shall come into operation on 31 July 2025.

Description of the map

The map shows the 30 & 40 mph Speed Limit zone on Various Roads, Abberley:

30 Miles Per Hour

A443: From a point 375 metres west of its junction with C2230 (The Common) in an easterly direction then a south easterly direction to a point 100 metres southeast of that junction. **B4202:** From a point 90 metres north of its junction with C2071 in a southerly direction to a point 215 metres north of its junction with A443.

40 Miles Per Hour

A443: From a point 100 metres southeast of its junction with C2230 (The Common) in a generally south easterly direction to a point 185 metres north of its junction with B4203.
