

# **NOTICE OF CONFIRMATION OF AN ORDER**

**WILDLIFE AND COUNTRYSIDE ACT 1981**

## **DEFINITIVE MAP AND STATEMENT FOR THE COUNTY OF WORCESTERSHIRE**

### **ADDITION OF CORRECT ROUTE OF FOOTPATH FH-624, DELETION OF INCORRECT ROUTE OF FOOTPATH FH-624 IN THE PARISH OF FECKENHAM AND CORRECTION OF PARTICULARS - MODIFICATION ORDER 2025 (2)**

On 26<sup>th</sup> of June 2025 the County Council Confirmed the above order without modification.

The effect of the Order as confirmed will modify the Definitive Map and Statement for the area by adding to them the correct route of footpath FH-624 (formerly No.108) leading from Swansbrook Lane to the unnamed road leading from Astwood Lane towards Swansbrook and deleting from them, the footpath from Ordnance Survey Grid Reference (OSGR) SP 0113 6180 (point A on the order plan). It commences in a generally northeasterly direction for 8 metres (m), then north for 39 m and east northeast for 127 m to a point on Swansbrook Lane (County Road U30008) at OSGR SP 0127 6186 (point B on the order plan).

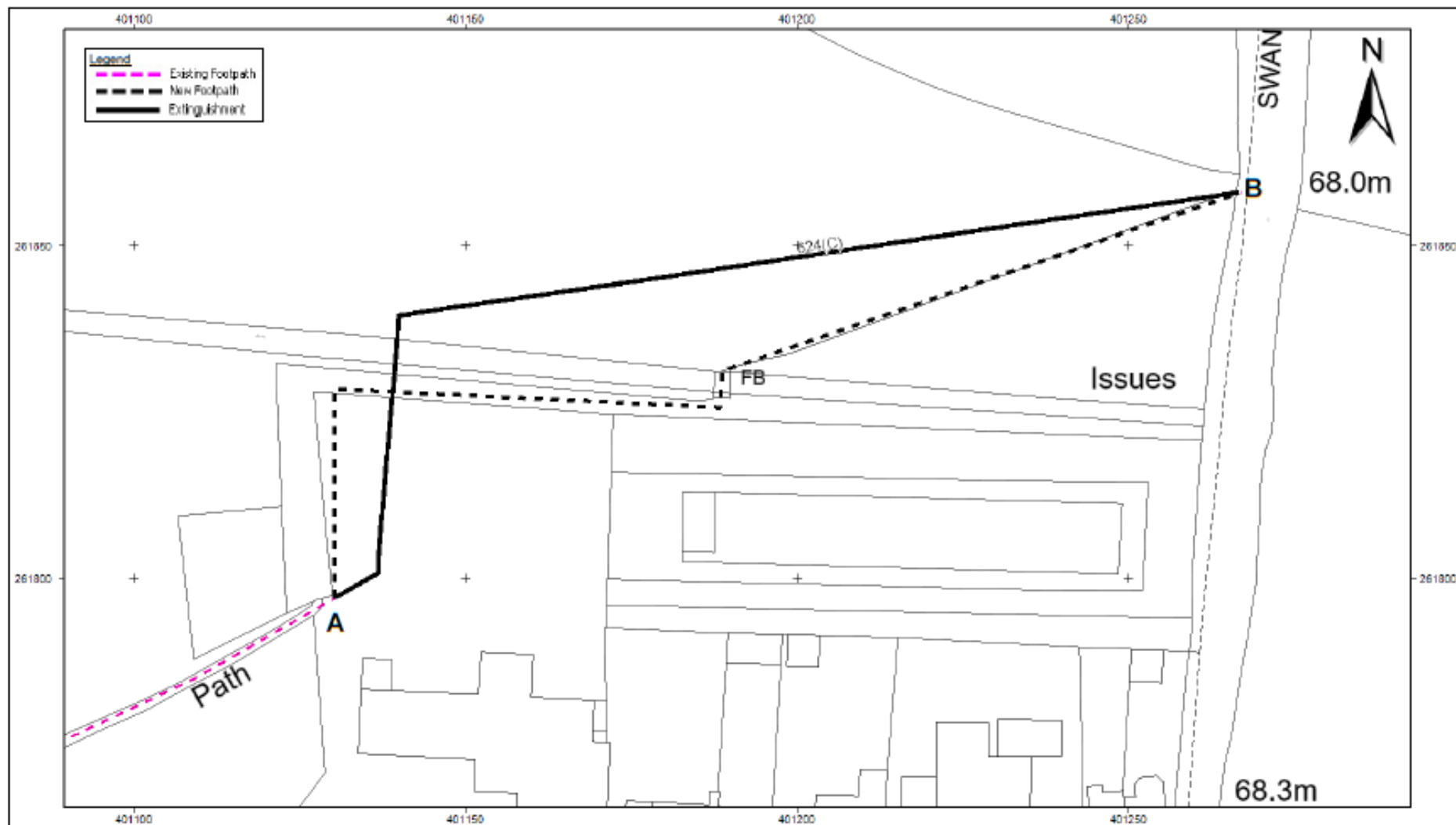

The Order becomes operative on 26<sup>th</sup> of June 2025 but if a person aggrieved by the Order-wants to question its validity, on the grounds that it is not within the powers of Section 53 of the Wildlife and Countryside Act 1981 or that any requirements of Schedule 15 to the Act have not been complied with in relation to it, they may under paragraph 12 of Schedule 15 to the Act, within 42 days from the date of publication of this Notice, make an application for the purpose to the High Court.
