**ADDITION OF CORRECT ROUTE OF FOOTPATH FH-624, DELETION OF INCORRECT
ROUTE OF FOOTPATH FH-624 IN THE PARISH OF FECKENHAM AND CORRECTION OF
PARTICULARS - MODIFICATION ORDER 2025 (2)**

This order is made by Worcestershire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to the authority that the Definitive Map and Statement for the County of Worcestershire require modification in consequence of the occurrence of events specified in section 53(3)(c)(i) of the Act, namely: that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path and Section 53(3)(c)(iii) of the Act, namely: that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. Worcestershire County Council hereby order that:

1. For the purposes of this Order the relevant date is 10th of April 2025.
2. The Definitive Map and Statement for the County of Worcestershire shall be modified as described in Part I and Part II of the schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as Worcestershire County Council Addition of Correct Route of Footpath FH-624, Deletion of Incorrect Route of FH-624 in the Parish of Feckenham and Correction of Particulars, Modification Order 2025.

Modification of Definitive Map

Description of path or way to be Deleted

The path to be deleted, commences at Ordnance Survey Grid Reference (OSGR) SP 0113 6180 (point A on the order plan). It commences in a generally northeasterly direction for 8 metres (m), then north for 39 m and east northeast for 127 m to a point on Swansbrook Lane (County Road U30008) at OSGR SP 0127 6186 (point B on the order plan).

Description of path or way to be Added

The footpath No.108 leading from Swansbrook Lane to the unnamed road leading from Astwood Lane towards Swansbrook.
