Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – STOURPORT ON SEVERN AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [EXPERIMENTAL PROHIBITION OF WAITING ON KINGSWAY, STOURPORT ON SEVERN]
