Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, BREDON'S HARDWICK) (40 MPH SPEED LIMIT) (PROPOSAL AND REVOCATION) ORDER 2025

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s122 Road Traffic Regulation Act 1984

1. That The County of Worcestershire (Various Roads, Bredon's Hardwick) (40 MPH Speed Limit) Order 2000 is hereby revoked in its entirety.
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads specified in the Schedule to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
4. This Order may be cited as Worcestershire County Council (Various Roads, Bredon's Hardwick) (40 MPH Speed Limit) (Proposal and Revocation) Order 2025 and shall come into operation on 11 September 2025.



1. No person shall drive or cause or permit to be driven any vehicle along the lengths of roads specified in the Schedule hereto at a speed exceeding 40 miles per hour.
2. This Order may be cited as Worcestershire County Council (Various Roads Bredon's Hardwick) (40 MPH Speed Limit) Order 2000 and shall come into operation on 3 February 2000.

C2272 Hardwick Bank Road: from its junction with B4080 for a distance of 90 metres in an easterly direction.
