## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [LIMITED WAITING (PROPOSAL AND REVOCATION) ON NEW STREET, UPTON UPON SEVERN]**

## Map and plan of the area

Map of New Street, Upton Upon Severn and the Limited Waiting zone implemented by the above order.

## Description of the map

The map shows the Limited Waiting zone on New Street, **Upton Upon Severn**:

**New Street (north side):** From a point 17.6m west of its junction with High Street for a distance of 41.7m in a westerly direction;

From a point 70m west of its junction with High Street for a distance of 3.8m in a westerly direction. From a point 77.7m west of its junction with High Street for a distance of 30.6m in a westerly direction;

From a point 131.5m west of its junction with High Street for a distance of 22.4m in a westerly direction.

**New Street (south side):** From a point 18.1m west of its junction with High Street for a distance of 68.2m in a westerly direction;

From a point 118.8m west of its junction with High Street for a distance of 16m in a westerly direction;

From a point 141.4m west of its junction with High Street for a distance of 18.6m in a westerly direction.
