## **Description of the map**

The map shows the Prohibition of Waiting zone on Thistledown, Evesham:

### Thistledown (northern arm)

(Both sides): from its junction with Cheltenham Road for a distance of 15 metres in an easterly direction.

## Thistledown (southern arm)

**Both sides:** from its junction with Cheltenham Road for a distance of 18 metres in an easterly direction
