Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – EVESHAM AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON THISTLEDOWN, EVESHAM]

Worcestershire County Council made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Description of the map

The map shows the Prohibition of Waiting zone on Thistledown, **Evesham**:

Thistledown (northern arm)

(Both sides): from its junction with Cheltenham Road for a distance of 15 metres in an easterly direction.

Thistledown (southern arm)

Both sides: from its junction with Cheltenham Road for a distance of 18 metres in an easterly direction
