# 2. Declaration of Interests

The Chair welcomed the new Cabinet Member Representative, Councillor Karl Perks (KP), and invited those present to introduce themselves.

# 5. Matters Arising

- Ratification of the WLAF Annual Report FY 24/25. Passed
- Findings of the BHS gates trial. The Chair invited Wendy Bannerman to provide a summary of the trial's findings and then expanded on a few points. JC covered a subsequent site meeting with 'Securafield' to discuss accessibility and advantages/disadvantages of existing gate design. Wendy Bannerman also covered a BHS scheme to support the purchase/repair of bridle gates.

# 6. Speakers - The National Trust Sandscapes Project – James Lawrence

James delivered an engaging and detailed account of the project and its place in wider National Trust environmental reinstatement programmes. He took questions on:

- Connectivity between NT sites and access areas in general (RL). James explained that NT are looking at the wider landscape beyond NT boundaries and read out the top level aims which include improving accessibility for all.
- NT's policy regarding the dedication of permissive routes, equestrian access and shared routes (Chair). James agreed to check the policy and provide more information postmeeting.

# 7. Public Rights of Way Team Report

Report presented by RL. Questions were taken covering:

- Recruitment of a new Enforcement Officer (Chair). RL explained that the paperwork to recruit to the empty posts had been submitted and was awaiting approval.
- Volunteer defect resolution numbers seemed unexpectedly high (GT). RL explained that, although supervised work parties were not yet reinstated, individual PPWs and self-managed parties were still able to tackle minor tasks.
- Deregulation Act and cut-off date for historic path claims (GB). No update on

implementation of the remaining PRoW legislation. The responsible role at DEFRA is reported to be vacant.

- Closure of bridleway bridge in Abberley (Chair & Gary Mascall). RL touched on the complications surrounding this long-standing case, but detailed discussions of specific closures is outside the usual remit of WLAF.
- The advantage of online recreational route guides over hard copy books (LB). RL agreed to look at the benefits of online guidebooks.
- Split between footpath and bridleway DMMO claims for ongoing cases and prioritisation criteria (Chair). RL said that applications are prioritised according to the publicly available scheme and determinations follow the evidence.
