Education Bulletin

Dear Colleagues,

A warm welcome to all new headteachers and staff joining us in Worcestershire this academic year. I trust you had a restful summer break and are returning refreshed and ready for the term ahead.

The first bulletin for this term is a bumper one - packed with updates that need your attention, action, or sharing as appropriate.

There's a new training opportunity for all professionals across Worcestershire who work with children, young people, or families. Free, high-quality online training is now available through the NHS Solihull Approach, offering flexible, self-paced courses on trauma, brain development, and attachment. Backed by the latest research in psychology and neuroscience, the training supports a trauma-informed approach and provides CPD accreditation. This training is fully funded by our Public Health team to support people who work with children and give every child the best start in life.

Herefordshire and Worcestershire Health and Care NHS Trust would like remind schools about a pilot project that was launched by the 0-19 Public Health Nursing Service on 1st August 2025. The pilot aims to enhance the health contributions to Initial Child Protection Conferences (ICPCs) for children and young people attending mainstream schools and home schooled CYP, by introducing a structured, systematic process for gathering health input using a Digital Health Questionnaire via the School Screener platform. And finally, I am pleased to share the latest update from the Worcestershire Public Health Nursing Service on health screening for school-aged children and young people. The <u>bulletin</u> provides an overview of key findings from the 2024/25 campaigns, outlines how identified health needs have been supported, and sets out the screening schedule for 2025/26. It also includes practical information for schools on upcoming health questionnaires and screening sessions. We encourage you to review the document and consider how the insights and support available can benefit your pupils and school community.

Latest Council News and Updates

Local Government Reorganisation

Under Government plans for Local Government Reorganisation for two tier areas in England, Worcestershire County Council and the six district, borough, and city councils will be abolished on 1 April 2028. Local Government will be replaced by either:

- a single unitary authority for Worcestershire running all services, or
- two unitary authorities one for the north and one for the south with each authority responsible for all services for its part of the county

A One Worcestershire options appraisal was submitted by Worcestershire County in February 2025, showing how dividing the council into two or more new councils would be less sustainable, effective and efficient than creating one new council. We are now developing a Strategic Business Case for One Worcestershire - providing detail on the practical and financial benefits of One Worcestershire. The final Business Case will be considered during October by our Overview & Scrutiny Performance Board and Full Council before it is submitted to the Government by 28 November 2025 to support the Ministry of Housing, Communities & Local Government (MHCLG) in making a determination about the future of local governance.

This week, district councillors in Bromsgrove, Malvern Hills, Redditch, Worcester City and Wychavon have held Special Council meetings and agreed that their preferred option is for two unitary councils to create a South Worcestershire Council and a North Worcestershire Council. Wyre Forest District Council agreed at its meeting on 26 February 2025 to support the case for one unitary council and will consider final reorganisation proposals later in the autumn.

The five districts supporting a two unitary council option will be developing their Strategic Business Case for consideration by their respective Councils ahead of the 28 November submission deadline.

Once the Minister of State has received proposals and undertaken an online public consultation, a decision will be made on the future governance for the area - there is no set timeline for this, but in order for Parliament to approve the process, it will likely need to be soon after the new year.

Once a plan is approved, the implementation period will begin. The new unitary authority or authorities is likely to go live in April 2028, known as 'Vesting Day', and will require election of a shadow council, appointment of shadow leadership roles, and a complex program of work to bring services together to deliver for the residents and businesses in the area.

We will keep you updated as work progress and key decisions are made.

Latest Education News and Updates

Pupil Premium for Children Previously Looked After reminder

FAO: School Designated Teacher, School Business Manager and Headteachers

This is a reminder to ensure all new pupils who arrived in September in your schools, who are eligible for Previously Looked After Children (PLAC) Pupil Premium (PP), are recorded on your school records and census returns.

Schools October Census return will determine the level of funding you receive for each designation of PP.

To qualify for PLAC status children need to have been in the care of a Local Authority, before a new order of permanence; that is Adoption, Special Guardianship Order or Child Arrangement Order (previously Residency Orders).

The Pupil Premium Plus funding for previously looked-after children in England for the 2025/2026 academic year is £2,630 per child.

Schools can access this funding by ensuring parents provide the necessary information and selecting the correct codes during the autumn census collection. The funding is not ringfenced for individual children but should be used to support their educational needs in consultation with parents and guardians. Inclusion in Practice Report

Following a national call for evidence to find examples of effective inclusive practice in mainstream schools, Inclusion in Practice and ImpactEd Group have published an emerging insights report laying out five principles of promising practice.

In a system navigating a complex and challenging funding backdrop, the report details how a number of schools and trusts are successfully organising practice, professional development and resources to strengthen support for all children. The five emerging principles of promising practice identified are:

- 1. Knowing children well, early and often.
- 2. High quality and evidence-informed teaching practice.
- 3. Coherent and expert targeted support.
- 4. Strengthening inclusion through relationships and partnerships.
- 5. Inclusion as a strategic and shared responsibility.

Whilst the call for evidence illuminates promising themes, it also showed the inconsistency in training, support, evidence-based guidance and resources that schools are navigating.

Funding for Before and After School Childcare

Are you experiencing additional demand for before and/or after-school provision? Do you have parents that are requesting later opening hours? We can provide funding to cover your additional staffing costs to extend your wraparound provision to meet the needs of your families.

Whilst it is still the Government's ambition to make 8am-6pm provision available to all families who need wraparound care for their primary aged children, there is new flexibility within the Wraparound Programme as we move into the final two terms of funding.

Funding is available to:

- Support any school/setting to increase their wraparound hours to at least 8am 5:30pm daily.
- Support any school/setting that is open at least 8am-5:30pm daily to increase the number of wraparound places they have on offer, as long as it will not adversely impact the demand for other local wraparound providers.
- Support schools/settings who can evidence that there is insufficient demand for 8am 5:30pm over 5 days per week, but who would like to extend their offer over a minimum of 3 days per week.

Funding can be used to cover staffing costs, purchase additional resources, support marketing costs to increase demand and/or to address other delivery barriers, with up to £500 per extended place available. Additional funding is also available to set-up new provision for pupils at schools without any wraparound provision.

Latest Attendance News and Updates

Back to School September Support – Attendance Helpline

Many schools recognise that pupils who are absent in the first week of term are often pupils that progress to have further persistent or severe levels of absence. Prioritising resources to be able to quickly identify pupils who may be missing during the first week of school, and ensuring a whole school 'support first' attendance approach is key.

Schools evidenced to be making positive impacts ensure they quickly 'notice' pupil absence, listen and respond to pupil voice, and provide timely support to work collaboratively with pupils and parents/carers to endeavour to remove any barriers that maybe preventing regular attendance.

To further support schools during the first week of September the LA attendance helpline will offer additional hours, opening daily from Tuesday 2nd – Friday 5th September between 9am -12.30 and 1-4.30pm.

From Monday 8th September the helpline will resume usual opening hours of Mondays, Wednesdays and Fridays between 9am - 12.30pm and 1pm - 4.30pm. Do call the helpline on 01905 844 440 should you require any attendance related advice, guidance or support.

School Transition

Starting at a new school can be an exciting but challenging time for children, parent/carers and schools alike. In ensuring smooth and successful transitions, schools are reminded of the following good practice and legal requirements:

- If a parent accepts an offer with the school place allocated, the child/young person must be
 placed on the expected admissions and attendance register.
 Schools are required to put on roll by the first day of term and follow non-attendance
 - processes if the child/young person fails to attend.
- If a parent wishes to reject the offer, an alternative education must be confirmed and in place before a rejection is accepted. The Admissions team will support this process. If an alternative education cannot be confirmed, the original allocated place at the school remains, and the child/young person must be placed on the expected registers.
 - Schools are required to put on roll by the first day of term and follow non-attendance processes if the child/young person fails to attend.

- If a parent neither accepts or declines the offer, a school place is allocated, and the child/young person is placed on the expected list.
 - Schools are required to put on roll by the first day of term and follow non-attendance processes if the child/young person fails to attend.
- If, in specific circumstances, a child is not going to be able to attend the allocated school place, and parents cannot provide an alternative education option:
 - The Allocated School is expected to engage with the parents to establish the reasons, encourage and support with attendance elsewhere, update the Admissions team and advise parents to do the same. Schools can also advise the CME team at cme@worcestershire.gov.uk.
 - The LA Admissions team will discuss alternative education options with the parents and will remind them of their parental responsibilities under the Education Act as well as the risk and consequences of becoming CME. Parents and schools will also be advised that unless an alternative education is identified a place can still be allocated at the school offered. In such circumstances the Admissions team will liaise with the CME team, who will monitor attendance/admissions in the new academic year and action as appropriate.

School Leavers

Many children will be making the phased transition to Middle or High school. Schools should not normally need to notify WCC of these children. However, in certain cases schools are requested to submit a Leavers Form if they are aware of any child who is due to make a statutory transition at the end of the academic year but:

- does not have an agreed destination,
- is leaving the county/country,
- is moving to the independent sector,
- parents have chosen to Electively Home Educate (EHE).

Additionally, if you are a school expecting a new child to start with you in September who does not attend, you are legally required to make all reasonable enquiries to confirm their whereabouts and safety. Schools are required to follow their usual non-attendance processes to engage with parent/carers to ascertain the reasons for absence, and to offer support to overcome any barriers preventing engagement. On occasion where you are advised the child or young person is no longer due to attend your school, or you are unable to make the required contact despite extensive efforts to do so, please inform the CME team via cme@worcestershire.gov.uk.

Please note: It remains an ongoing statutory requirement that all schools are expected to advise the LA of any in-year leavers, selecting a legal reason for removing from roll via the Children's Services Portal. This is the expected method of notifying the local authority of school leavers and should always be completed even if another service/team in the authority has also been advised.

CCAS Process Updates

Over the last 12 months, the team have responded to approximately 3000 absence notifications with any needing further discussion or support being contacted by the team within days. This is a vast improvement on response times previously. As a result, the Absence Monitoring Team have been able to spend the summer holidays further reviewing some of the processes around the notifying of children who potentially need to be discussed at CCAS panel and the outcomes that followed. These improvements, listed below, have been based on our own experiences and feedback from schools, parents and other professionals.

- 1) The team have found that there is a large variation in the quality and quantity of information provided as an absence notification especially where the CCAS panel tick box is selected. To support with this and ensure we receive useful and complete information we have put together the CCAS Supporting Information Form (also available via email from ccas@worcestershire.gov.uk) that can be attached to an absence notification being completed through the ChS portal. This should be used by schools to help confirm they are supporting a child fully and are providing the information required to allow us to make a quicker decision on whether a child might need to be discussed at CCAS panel. We have tried to ensure the form is both informative whilst also hopefully not becoming a burden on schools to complete. Please note that each case is considered on its own and completing the CCAS Supporting Information Form does not necessarily guarantee a discussion at CCAS panel (especially if an alternative option is in the best interests of the child).
- 2) Following a discussion at CCAS panel, we will now send out an outcome email documenting the result and any actions for school, ourselves or other attendees. This email can and should be passed to parents for their information.
- 3) The team will be contacting schools more often to review children who are receiving support via CCAS panel/s19 we would also request that schools contact us as soon as possible if any issues arise or the situation is not improving.

Please note schools must continue to share absence notifications, part-time/reduced timetable (and flexi-schooling) notifications, joiners and leavers.

Latest Public Health News and Updates

Clean Hands, Safe Hands

The Public Health Team at Worcestershire County Council would like to remind you of the 'Clean Hands, Safe Hands' handwashing campaign. Hand hygiene is one of the most effective and simple ways to prevent the spread of infectious diseases.

Instilling proper handwashing habits in children is especially crucial, as it empowers them to safeguard their own health and that of those around them. Young children, whose immune systems are still developing, are particularly susceptible to common infections found in schools, nurseries, and playgrounds. By teaching them the correct way to wash their hands and explaining why it matters, we help break the chain of transmission for illnesses, reducing absences and promoting a healthier learning environment. Early education around hand hygiene not only protects children in the present but also shapes lifelong habits that contribute to the wellbeing of entire communities.



As part of the campaign, the Public Health team are offering interactive learning sessions for schools, nurseries and sessions. The sessions will take approximately 1 hour to complete and will be carried out in person by the team.

- Each lesson will be interactive with activities for children to complete.
- These activities will include the opportunity to demonstrate effective hand washing using an
 Ultraviolet Lightbox. A UV gel is applied to the children's hands which they will then be asked to
 wash off. When they then put their hands in the lightbox any areas which they have missed will
 glow.
- Sessions can be carried out at any setting including schools, nurseries, colleges, day care centres and after school clubs.
- The session will be hosted by the Public Health team at each setting.
- The lessons are tailored for different age groups.
- The lessons will teach pupils why handwashing is important and how to wash and dry their hands effectively.
- The team will have 'clean hands safe hands' merchandise such as stickers and badges to give to children at the end of the lesson.

Measles

Measles continues to be a concern with recent data showing a high level of cases, leading to fears of a further surge once education settings return in September.

Measles can be a very serious infection, especially if it spreads to other parts of the body, such as the lungs or brain, and can cause pneumonia, meningitis, blindness, and seizures (fits).

Measles usually starts with cold-like symptoms, followed by a rash a few days later. Some people may also get small spots in their mouth. The rash usually starts on the face and behind the ears before spreading to the rest of the body. The spots of the measles rash are sometimes raised and join together to form blotchy patches. They're not usually itchy and look brown or red on white skin. It may be harder to see on brown and black skin.

Measles is one of the easiest diseases to catch through coughing or sneezing. It can spread quickly from person to person, especially in schools and a child with measles will infect almost all unprotected children they have contact with. The most effective way to control measles is by having 2 doses of measles, mumps, and rubella (MMR) vaccine.



MMR vaccination

Outbreaks can occur in schools when not enough children have been vaccinated.

Whilst MMR vaccines are usually delivered as part of the routine childhood immunisation programme, this may have been missed due to a number of reasons. It is never too late to catch up and parents should be encouraged to speak to their GP if they are unsure if their child has received the vaccination or to arrange for it to be given.

Response to a case

Individuals with measles infection are infectious from about 4 days before rash onset until 4 full days after the rash appears. If you suspect a child has a case of measles or you are notified of a confirmed or suspected case, please contact UKHSA immediately for support and advice on 0344 225 3560 Option 2.

Unvaccinated contacts of a confirmed case of measles

Unvaccinated individuals exposed to measles, may be advised to isolate for up to 21 days to prevent potential transmission, as the incubation period for measles can range from 7 to 21 days. UKHSA will provide clarification of isolation periods on a case-to-case basis.

Respiratory syncytial virus (RSV)

RSV is one of the common viruses that cause coughs and colds in winter. RSV is transmitted by large droplets and by secretions from an infected person. Infants under one year of age and the elderly are at the greatest risk of developing severe disease. While most RSV infections usually cause mild illness, infants aged less than 6 months frequently develop the most severe disease such as bronchiolitis and pneumonia, which may result in hospitalisation.



Since 1 September 2024, two new respiratory syncytial virus (RSV) vaccination programmes been introduced.

Programme for pregnant women to protect infants

All women who are at least 28 weeks pregnant (the eligible cohort) on 1 September 2024, will be offered a single dose of the RSV vaccine. After that, pregnant women will become eligible as they reach 28 weeks gestation and remain eligible up to birth.

Programme for older adults aged 75 to 79 years old

All adults turning 75 years old on or after 1 September 2024 will be eligible for routine programme and should be offered a single dose of the RSV vaccine. A catch-up campaign for those already aged 75 to 79 years old on 1 September undertaken at the earliest opportunity.

Influenza (Flu)

Flu is a viral infection affecting the nose, throat, and lungs, mostly during the winter months. It is far worse than an ordinary cold, which usually causes a runny nose, sneezing, watery eyes and throat irritation. Symptoms of a cold usually occur gradually without causing a fever or body aches, which usually occur with flu.

Flu can lead to serious illness, especially in children, with more than 8,000 hospitalisations last winter. Older people, those with a weakened immune system, and people with long-term health conditions are at higher risk. Over the past 2 winters, at least 18,000 deaths were associated with flu.

Children and staff with symptoms of flu such as a high temperature, cough and feeling tired and achy, should try to limit their contact with others, especially those who are vulnerable. Washing hands regularly and using and disposing of tissues in bins can help to reduce the spread of flu.

Changes to national flu immunisation programme 2025 to 2026

Community pharmacies will be now able to offer 2-3-year-olds flu vaccinations during the 2025 to 2026 flu season. Community pharmacy service delivery will begin from 1 October 2025, supplementing the offer in General Practice who will start vaccinating from the 1 September 2025, or as soon as vaccine is available.

Children under 5 have the highest hospitalisation rate from flu. Vaccination cuts the risk of hospitalisation by about two thirds. Vaccinating children also helps to protect their family as it reduces the risk of them spreading the flu virus to parents and grandparents.

The nasal spray helps protect against flu, has been given to millions of children in the UK and worldwide, and has an excellent safety record. In the last few years, the protection that children get from vaccination has been consistently higher than for adults. The vaccine is updated yearly to match flu strains, so it is recommended that children are vaccinated yearly, even if vaccinated last year.

Education and childcare settings have a vital role to play to support the routine immunisation programme including the flu vaccine. Sharing information with parents and caregivers at key points and encouraging parents to sign their consent form can help in ensuring children and their families are protected.

Pregnant women

It's recommended that all pregnant women have the flu vaccine, whatever stage of pregnancy they're at. The vaccine is free for pregnant women and has been shown to be safe during any stage of pregnancy, from the first few weeks up until labour.

Pregnancy changes how the body responds to infections such as flu. There is good evidence that pregnant women have a higher chance of developing complications if they get flu, particularly in the later stages of pregnancy. Young babies also have a higher risk of getting seriously ill if they get flu.

Having flu increases the chances of pregnant women and their babies needing intensive care.

Women who have had a flu vaccine while pregnant also pass some protection on to their babies. This lasts for the first few months after they're born, when they're particularly at risk from flu.

Shiga Toxin producing E. coli (STEC)

The latest UK Health Security Agency (UKHSA) annual data has shown a 26% rise in Shiga toxin-producing Escherichia coli (STEC) infections in England in 2024 when compared to 2023.

STEC are bacteria that can cause gastroenteritis. In severe cases, they can cause haemolytic uraemic syndrome (HUS). STEC bacteria are spread through contact with animals or their faeces, consuming contaminated food or water, and from person to person.

Common symptoms of STEC include diarrhoea, stomach cramps and fever. Around 50% of all cases will experience bloody diarrhoea however, some people may only have mild diarrhoea. Symptoms can last up to 2 weeks in cases without complications. A small proportion of patients, mainly children, may develop haemolytic uraemic syndrome (HUS) which is a serious life-threatening condition resulting in kidney failure. A small proportion of adults may develop a similar condition called thrombotic thrombocytopaenic purpura (TTP).

As with other illnesses which include symptoms of diarrhoea or vomiting children, and staff should not return to the setting until they have been clear of symptoms for 48 hours.

Risks associated with slush ice drinks containing glycerol

The Food Standards Agency (FSA) has launched a new campaign to warn parents and caregivers not to give children under 7 slush ice drinks or 'slushies' containing glycerol. The FSA also advises that children aged 7 to 10 should have no more than one 350ml 'slushie' drink with glycerol per day – roughly the size of a fizzy drink can.

At very high levels of exposure, typically when several servings of these products are consumed by a child in a short space of time, glycerol can cause shock, very low blood sugar levels and loss of consciousness.



Sexual Health Week 2025 - Chronically Online

This year's sexual health week will be running between the 15th and 21st September with a focus on the impact on children of online content.



Digital technology has become integral to how we manage relationships and wellbeing, from dating apps to online STI tests. However, the rapid advances in AI are raising new questions about the future of sexual health and relationships, including the impact of deepfakes, ChatGPT romances, and social media algorithms on public perceptions of contraception and gender stereotypes.

For Sexual Health Week 2025, the focus is on how being "Chronically Online" influences attitudes and behaviours around sex and relationships. The week will explore how RSE can empower young people to critically evaluate content, integrate digital and face-to-face sexual health services to address health inequalities, and amplify voices combating stigma and misinformation online.

As part of the campaign, Brook is inviting schools to attend 'the Big RSE Lesson' on 16th September at 10am. The free, 60-minute live broadcast is aimed at children in year 9 and above and will combine real life stories with expert advice, the lesson aims to equip young people with the knowledge and confidence to understand and manage how online content can influence their sexual health and relationships.

Management of Asthma in Schools

FAO: Headteachers, Pastoral/Welfare Leads and First Aiders

Death rates from asthma are highest in children aged 15 to 17 years old.

Children living in more deprived areas are 4 times more likely to die from asthma.

These deaths are avoidable. Good management of asthma is crucial for avoiding asthma deaths and can reduce school absences of which asthma accounts for 18%.

Asthma prevention needs to be actively managed in schools.

Herefordshire and Worcestershire Integrated Care Board have recently produced Guidance on the Management of Asthma in Schools. The guidance can be accessed via the Google Drive here.
