Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (BROMSGROVE DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [DISABLED PERSONS' PARKING SPACE ON CHARFORD ROAD, BROMSGROVE]

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a Disabled persons' Parking Place in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2025 and may be cited as Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2025 [Disabled Person's Parking Space on Charford Road, Bromsgrove].

Description of the map

The map shows the proposed **disabled persons' parking space** on Charford Road, **Bromsgrove**:

Charford Road (south side) from a point of 239 metres west of its junction with Lyttleton Avenue for a distance of 6.6 metres in an easterly direction.
