### **Description of the map**

The map shows the proposed **disabled persons' parking space** on Charford Road, **Bromsgrove:** 

**Charford Road (south side)** from a point of 239 metres west of its junction with Lyttleton Avenue for a distance of 6.6 metres in an easterly direction.
