#### **Description of the map**

The map shows the proposed prohibition of waiting zone on Squires Walk and Squires Close, **Kempsey:** 

**Squires Walk (north side)** from its junction with Squires Close for a distance of 10 metres in a south westerly direction and 8.3 metres in a north easterly direction.

**Squires Close (west side)** from its junction with Squires Walk for a distance 13.7 metres in a northerly direction.

**Squires Close (east side)** from its junction with Squires Walk for a distance 15 metres in a northerly direction.
