## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON SQUIRES WALK AND SQUIRES CLOSE, KEMPSEY]**

Worcestershire County Council propose to make this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

## **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON SQUIRES WALK AND SQUIRES CLOSE, KEMPSEY]**

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and sides of road identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on **XXXX 2025** and may be cited as Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2025 [Prohibition of Waiting on Squires Walk and Squires Close, Kempsey]

## Map and plan of the area

Map of Squires Walk and Squires Close, Kempsey and the proposed prohibition of waiting zone to be implemented by the above order

### Description of the map

The map shows the proposed prohibition of waiting zone on Squires Walk and Squires Close, **Kempsey**:

**Squires Walk (north side)** from its junction with Squires Close for a distance of 10 metres in a south westerly direction and 8.3 metres in a north easterly direction.

**Squires Close (west side)** from its junction with Squires Walk for a distance 13.7 metres in a northerly direction.

**Squires Close (east side)** from its junction with Squires Walk for a distance 15 metres in a northerly direction.
