The map shows the Revocation and Proposed Waiting Restrictions on Abbey Road/Abbey Lane, **Evesham:**

U44401 Abbey Lane (Both sides) – All waiting restrictions over its entire length. New Restrictions

U44401 Abbey Lane (Both sides) – No Waiting At Any Time over its entire length. Abbey Road (West Side) - No Waiting At Any Time - from a point 28m north of its junction with U44401 for a distance of 47m in a northerly direction.
