Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON WYRE HILL & CLEOBURY ROAD, BEWDLEY]

Map of Wyre Hill & Cleobury Road, Bewdley and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on Wyre Hill & Cleobury Road, **Bewdley**:
Cleobury Road (southeast side) - from its junction with Wyre Hill for a distance of 10m in a north easterly direction.

Wyre Hill (north side) - from its junction with Cleobury Road for a distance of 46.3m in an easterly direction.

Wyre Hill (south side) - from its junction with Cleobury Road for a distance of 59m in an easterly direction.
