Description of the map

The map shows the Prohibition of Waiting zone on Wyre Hill & Cleobury Road, **Bewdley:** Cleobury Road (southeast side) - from its junction with Wyre Hill for a distance of 10m in a north easterly direction.

Wyre Hill (north side) - from its junction with Cleobury Road for a distance of 46.3m in an easterly direction.

Wyre Hill (south side) - from its junction with Cleobury Road for a distance of 59m in an easterly direction.
